#### **PREAMBLE**

WHEREAS, it is the express purpose of God, our Heavenly Father, to call out of the world a people who shall constitute the Body of Lord Jesus Christ, built and established upon the foundation of the Apostles and Prophets through local churches and fellowships, Jesus Christ Himself being the chief corner-stone;

KNOWING that students who share in the same body of Jesus Christ must needs continue to exercise their faith and spiritual gifts when at their various institutions of learning through local assembly of true Christian church for teaching in the Word of God and power of the Holy Spirit;

**RESEOLVED** that there is no such organized church in Bugema University, we whose names appear on the roster above do recognize ourselves as Fellowship, registered as Faith Based Organization with Busika Town Council.

### SECTION I: NAME, VISION AND MISSION

- a. NAME: The name of the Fellowship shall be Bugema University Christian Union, hereby abbreviated as BUCU, with the registered office at Busika Town Council, Luwero District.
- b. **MOTTO:** "...not by might, nor by power, but by My spirit, says the LORD of hosts...
  (Zechariah 4:6-7 KJV).
- c. VISION: Christ-transformed students and associates, impacting the university and community
- d. **MISSION:** To engage and equip students of Bugema University and the Community for effective, Christian living.

# SECTION II: CORE VALUES, AIMS & OBJECTIVES a. CORE VALUES

Bugema University Christian Union shall stand of 4 core values, as stated below:

- 1. Christ-centered Fellowship
- 2. Unity
- 3. Discipleship
- 4. Integrity

## AIMS AND OBJECTIVES

- 1. To hold gathering for services, fellowships and prayers on regular basis; daily fellowships, weekly services, monthly overnights, intercessions, prayers and fastings.
- 2. To hold bible study and discipleship gatherings for all members
- 3. To conduct evangelistic crusades, outreaches and campaigns on regular basis
- 4. To liaise with other churches of like faith in carrying out her Christian duties
- 5. To appoint members to leadership positions on regular basis
- 6. To provide spiritual, social and emotional support to members in need
- 7. To acquire properties for the fellowship, in growing the fellowship potential and capacity in impacting Bugema with Jesus Christ
- 8. To develop, equip and send out members for Christian work, from time to time
